YOUTH ORGANIZATION SPONSORED BY A BUSINESS - \$30

No entry fee will be charged for bands, or children entering as an individual.

Royalty entrants are required to be on a float. No entry fee will be charged for high school royalty. Call the Chamber for information and a business partner.

JUDGING: Floats (competitive only) will be judged at 6:00 p.m. and must be in the parade lineup at that time.

PARADE Your entry will receive a number corresponding with your position in the parade.

FORMATION Markers along the parade lineup area will indicate your position. The contact person

Area: for your business or organization will receive parade lineup, parade number, map, and cover letter two weeks before the parade.

LIGHT This is a lighted parade and all vehicles not used to pull a float must be

REQUIREMENT: lighted and decorated

Trucks or busses – 5,000 light minimum;

Automobiles (excluding Classic Cars) –1,000 light minimum.

DO NOT bring a passenger car into the formation area unless it is entered in the parade.

NO CANDY may be distributed along the parade route while the parade is in progress.

NO SANTA CLAUS figure is allowed on a float, or in the parade other than the official Santa.
